NMDC Energy (formerly NPCC) was established in 1973. Together with its subsidiaries, it provides engineering, procurement, and construction services to both offshore and onshore clients in the energy industry.

NMDC Energy has historically executed over 1,200+ projects which comprise approximately 1,360 installed structures, approximately 8,000 kilometers of laid pipelines both onshore and offshore, and approximately 2,000 kilometers of marine cables. It primarily operates in the UAE, Saudi Arabia, India, Kuwait, and Taiwan.

NMDC Energy operates four (4) fabrication yards namely: Mussafah Yard, ICAD4 Yard, Modular Fabrication Yard and KSA Yard. Mussafah Yard is considered one of the largest fabrication yards in the Gulf Cooperation Council region. NMDC Energy has eighteen (18) offshore vessels comprising of heavy lift and pipelay vessels, pipelay barges, jack up barges, cable laying barges, anchor handling tugs, and transportation cargo barges.

NMDC Energy has a project backlog of approximately AED 54 billion, underpinning its future performance and growth prospects. This backlog encompasses a diverse portfolio of high-value onshore and offshore projects in the market it operates.
